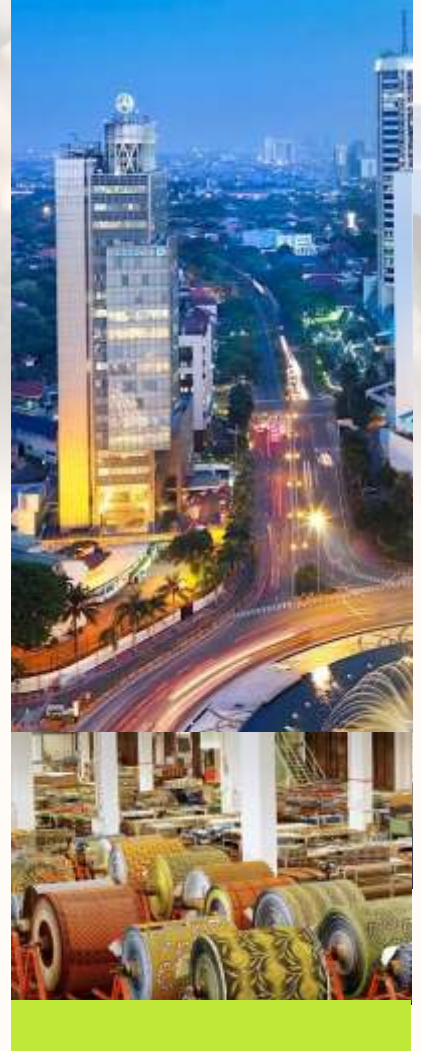
# About

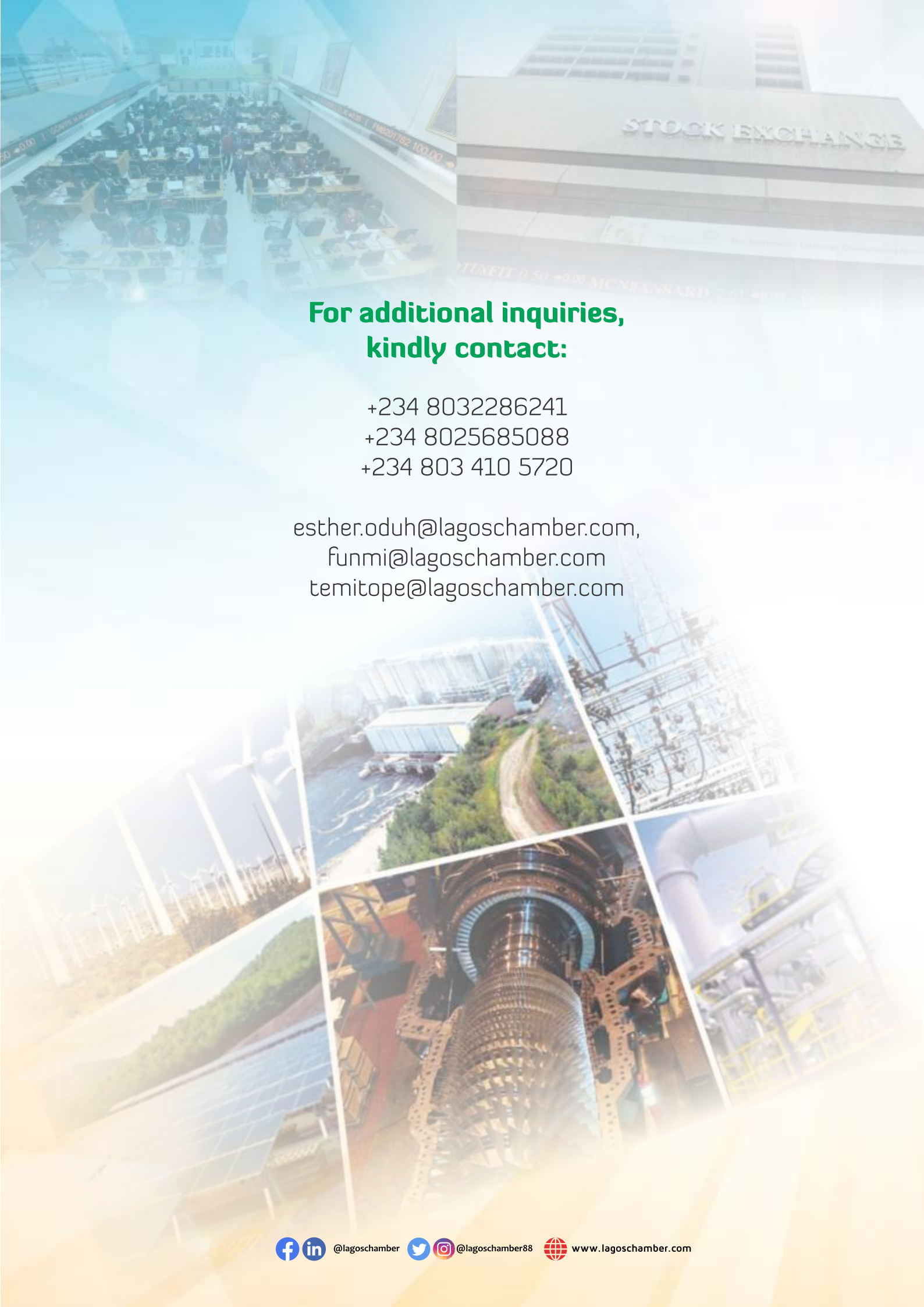
